- ✓ EOP program available only in California, Texas, and Arizona.

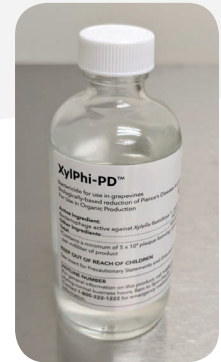
