



Corteva Agriscience is offering a guarantee on Kerb SC® for Poa annua control.

## Program guidelines

<b>Greens</b>	Kerb® SC specialty herbicide 30 to 40 oz/A (0.75 lbs a.i.)	Apply between October 1 and December 31, 2025
<b>Non-overseed Turfgrass</b>	Kerb SC 40 to 60 oz/A (1.0 lbs a.i.)	
<b>Non-overseed Turfgrass</b>	Kerb SC 30 oz/A (0.75 lbs a.i.) + Dimension® 2EW specialty herbicide 32 oz/A (0.5 lbs a.i.) OR Crew® specialty herbicide 200 lbs/A	
<b>Overseed Turfgrass</b>	<b>1st Application:</b> Dimension 2EW 32 oz/A (0.5 lbs a.i.) OR Crew 200 lbs/A	<b>1st Application:</b> 6 weeks before overseed
	<b>2nd Application:</b> Dimension 2EW 32 oz/A (0.5 lbs a.i.) OR Crew 200 lbs/A	<b>2nd Application:</b> After overseed is established, or when turfgrass is well established with a good root system and a uniform stand and has received at least two mowings

**Guaranteed\* 90% Poa Control through April 15, 2026**

When using Kerb® SC specialty herbicide, treated areas must receive ¼ to ½ inch irrigation immediately following product application.

**IPM Statement:** Poa annua has evolved resistance to every effective mode of action that has been widely used to control this weed. To limit the spread of resistant Poa, there must be a rotation of products with differing modes of action, or applications of combination treatments with 2 or more modes of action. For further resistance management techniques and guidelines, please refer to Kerb SC specialty herbicide label.

Higher amounts of rainfall and/or higher than average temperatures might make it necessary for higher rates or a repeat application to achieve adequate control. Lack of control the previous year/season due to potential resistance should be met with university plant testing or earlier application timing. It is important to contact your local Corteva territory manager to determine the best choice for poa control.

A preemergent herbicide application for control of crabgrass and other spring/summer weeds must be applied after February 1, 2026, and prior to March 15, 2026, or prior to target weed germination.

### Program requirements:

- Kerb® Specialty Herbicide applications at 30 oz/A made between October 1, 2025, and December 31, 2025, qualify for guarantee through April 15, 2026.
- A preemergent herbicide application for control of crabgrass and other spring/summer weeds must be applied after February 1, 2026, and prior to March 15, 2026, or prior to target weed germination.
- Corteva must be notified within 30 days of application for service policy to be in effect unless otherwise stated.
- Product must be applied at rates and application timing as outlined herein.
  - » **Greens:** 1.8 pints of Kerb® SC specialty herbicide equals 0.75 lb active ingredient.
  - » **Fairways:** 2.5 pints of Kerb SC equals 1.00 lb active ingredient.
- Treated areas must receive ¼ to ½ inch irrigation immediately following product application.
- A small area of the course must be left untreated as a check strip. The area should be at least 500 sq. ft. and can be in a less noticeable area of the course.
- If less than 90% control of Poa annua is obtained and documented and all other program requirements are met; the product applications, as verified by a Corteva Agriscience customer service report, may qualify for program payment.
- Program payment shall not exceed the cost of original material purchase price, and is limited to the Kerb SC component of the formulation used.
- All Kerb SC and Kerb SC/Dimension® 2EW specialty herbicide non-performance claims will be handled by Corteva Agriscience sales representatives (in conjunction with the selling Distributor Representative).
- Avoid spraying Kerb SC on hillsides, fairways, or approaches that may drain onto bentgrass greens or other sensitive cool season grasses.
- Any applications of Dimension 2EW or Crew alone must be applied prior to poa germination. Please work with your Corteva Territory Manager to determine best timing.
- To receive program payment for non-performance, all non-performance claims must be reported to your Corteva Agriscience representative by no later than April 15, 2026. Non-performance claim must exceed 10% of treated turfgrass area to be eligible for program payment. Payment will be made in the form of a check within 28 days of report completion.

### Terms and Conditions Related To Use Of Corteva Agriscience Turf and Ornamental Products And This Service Policy

- Corteva retains the right to reject claims that do not meet all terms and conditions of its service guarantee, as well as the right to investigate any situation where fraud is suspected. Void where prohibited by law.
- All Corteva Agriscience products are to be used at labeled rates, and according to program recommendations herein.
- Claim Payment does not include application or adjuvant-related costs.
- Please consult product labels and/or your Corteva sales representative for adjuvant and mixing instructions.
- To determine the use and proof-of-purchase requirements, Corteva may request the following documentation to verify the use of a Corteva Agriscience product by the grower:
  1. An invoice of the Corteva product purchased from their retailer
  2. A verified EDI transaction record from the distributor to the retailer who sold the Corteva product to the grower
  3. If the retailer who sells the product to the grower has no EDI transaction, then an invoice trail leading to a retail EDI transaction must be shown to support the purchase.
- Corteva will make approved program payments after all required documentation is submitted and approved
- All decisions made by Corteva with respect to service guarantee implementation and administration, including the calculation of program payments, shall be final and binding.
- Participation in this program is subject to any terms, conditions and procedures that Corteva may adopt, at its sole discretion.
- Corteva reserves the right to modify or terminate this program at any time without prior notice.
- Corteva retains the right to audit customer's records for compliance including earnings, and all such earnings will be forfeited if records are determined to be false.
- Where permitted by law, Corteva may deduct from program payments any amount due
